In order to apply and be considered for Provisional Recognition, each State must fulfill, comply and submit the following:

1. **Covering Letter of Application**
2. **1-Year Development Plan for the State**

* Once the above documents have been submitted and approved, the State **NMGFI** Association will be granted a 1-Year Provisional Affiliation from **NMGFI** & then after State Association must submit below documents within 2 months from yours **Provisional Membership**. If you fail to do same then GFI have right to cancel yours **Provisional Membership**.

1. Certificates of Registration under Charity Commissioner, Society, Company & Trust Act.
2. Bye Laws of the Society, Names & Addresses of the Office Bearers & other relevant details.

- * The Provisional Affiliation will empower the State **NMGFI** Association to carry out **Martial Arts Masterships Sports** development activities within their region, under the guidelines of **NMGFI** mentioned below...
- To spread **Martial Arts Masterships Sports** in all over State.
- To conduct at least 1 Educational Camp for District Units, under the supervision of **NMGFI** representatives in the first 3 months of being granted provisional affiliation.

On the basis of the 1-year performance review, the Provisional Recognition will be extended. However, in the event that the State **NMGFI** Association fails to comply with the **NMGFI** guidelines, their Provisional Affiliation may be suspended and/or cancelled. Affiliation Fee: Rs 10000 per year, **FIRST TIME:** you must pay Registration Fee + Annual Fee together. **Registration Fee** is : 5000 Rs. (Only One Time) & **Annual Fee** is 10000 Rs. Yearly. Total=15000 Rs.

1. Definition of NMGFI Membership:

- All State associations/ Individual Member/ Clubs/Academies those have their annual membership to **NMGFI** and have agreed to the terms and conditions of **NMGFI**.
- **NMGFI** membership does not release the member of other taxes and fees related with **NMGFI** events.
- The membership is valid for one year from the 01 April Or Joining Date to 31st March.
- The membership Certificate entitles the user to the benefits associated with the membership.

- The membership is not transferable and must only be used by the registered member. Any misuse of the membership will result in the membership being cancelled.

2. Membership Requirements:

- Applicants must present accurate information when filling the registration form.
- Applicants must attached all the documents required in order to complete the registration process.

- You agree to provide accurate, current, and complete information required to register with **NMGFI** and at other points as may be required in the course of using the Service.
- You further agree to maintain and update your Registration Data as required to keep it accurate, current, and complete. **NMGFI** may terminate your membership if any information you provide is false, inaccurate or incomplete.
- **NMGFI** allowed a player to represent State as long as the player held residence of that State.
- The regulation concerns players' eligibility to play for the **State** where they reside only. A significant ruling that requires a player to demonstrate a "clear connection" to State they wish to represent.
- Players are generally not allowed to switch their State Association.
- Applicants must present accurate information when filling the registration form. The integrity of sports depends on the players outcome of sporting events and competitions being based entirely on the merits of the participants involved. Any form of corruption that might undermine the integrity of the spirit of sport and subject to severe sanctions.
- **NMGFI** Members must act with discipline, respect and follow the instructions given by **NMGFI** staff. Acts of misconduct, lack of respect, bad behaviour and will to cooperate will not be tolerated. If you don't cooperate, after receiving 2 warnings, your membership will be terminated.
- If a contest takes place and seems to have been played to a pre-determined result, violating the **NMGFI** rules, further investigation may be undertaken and any findings of match will result in disciplinary action.
- If in **NMGFI** events, an athlete is injured or ill before a competition or contest and needs to withdraw they must have inform to remove from brackets or inform the competition manager.
- The result of the contest will be cancelled if any athlete is caught not telling the truth.
- The **NMGFI** may undertake further investigation and any findings of match will result in disciplinary action.

3. Membership Benefits

- Members of **NMGFI** will be allowed to compete in all events organized by **NMGFI** according to the rules of the competition.
- Members of **NMGFI** will receive special rates and discounts on products.
- Members of **NMGFI** will have database file with all achievements and progress.
- The personal information stored in **NMGFI** system will allow **NMGFI** to follow logistics and other matters.
- Members of **NMGFI** agree that will have their personal file showing all competition achievements for collecting quotas and marketing purposes.
